MSC. 34 35 36 III. **OFFICER'S REPORTS** 37 President's Report: 38 Kurs opened congratulating Hughes and Staff for obtaining \$275,000 funding for the demolition of the annex building from Councilmemeber Jose Huizar's office. The money will be used for demolition and 39 40 removal of the asbestos from the annex building. LACD will have a meeting on May 16, 2009 to discuss a possible donation for the demolition of the annex building. There might be more budget cuts after the 41 special election on May 19, 2009. Arce stated that if the propositions do not pass the State will be in a 42 43 fiscal emergency once again. 44 45 Vice President's Report: 46 No report 47

1 Treasurer's Report:

- 2 Schultz referred to hand out of Controller's Report as of today's date. Year to date (9 months) profit and
- 3 loss as of March 31, 2009 is \$93,378 (a profit) as compared to last year's year to date profit and loss which
- 4 was \$(55,006) (a loss). The cash position today for DAHC, GLAD and LifeSigns is \$1,041,425. The
- 5 overall accounts receivable balance is \$860,313. GLAD balance is \$357,477. LifeSigns balance is
- 6 \$502,836. The overall accounts payable is \$20,249. GLAD's year to date revenues is \$79,499 more as
- 7 compared to prior year to date. LifeSigns's year to date revenues is \$386,549 more as compared to prior
- 8 year to date due to more interpreting requests. GLAD's current aging accounts receivable balance is
- 9 \$647,492 as compared to prior month's balance of \$565,308. LifeSigns's current aging accounts
- receivable balance is \$583,294 as compared to the prior month's balance of \$559,041.

- LA, OC, TRI, and CODIE got more requests than during the month of February.
- 26 LA office will have only two staff interpreters and we need your assistance in recruiting interpreters to
- apply for two openings here.

29 HUMAN RESOURCES

30 As of April 28, 2009 we have 75 employees. We have 4 job openings.

31

32 HUMAN SERVICES

- 33 Trends: More medical providers are refusing to pay for interpreters, blaming it on poor economy.
- Most job openings are still on a freeze, likely until the end of the summer or possibly for one year. For
- example, the Kodak Theatre let go of the Human Resources Manager as the position is expensive to keep.
- 36 More job seekers are becoming flexible to positions being available rather than keeping their original
- objectives due to fewer choices.
- More hard of hearing job seekers are debating if they should disclose their hard of hearing status in order to
- 39 obtain accommodations which may lead employers not to hire them.

40

- 41 Challenges: More job fairs are being held. There is a dramatic increase in sales and marketing positions
- 42 and those positions require degrees or certificates. This seriously limits consumer opportunities and hurts
- 43 their confidence.

- 45 Consumer Successes:
- Siblings of a deaf child chose to participate in GLAD's ASL classes rather than stay in the play room so
- 47 they could learn how to communicate with the sibling.
- 48 Our EDD staff practices a variety of scenarios with consumers including assertiveness skills. One job
- seeker interviewed for a hotel position for which she has experience. The employer gave her a short

- 1 interview and told her that there was no opening. The consumer believed that it might be a case of
- 2 discrimination and asked the interviewer to be interviewed by another staff person for another position.
- 3 She got the job thanks to self advocacy skills taught by our staff. Hands waving.

- 5 Health Education
- 6 GLOW was a great success. 151 young people attended. Both the Mayor and Councilman Cardenas sent
- 7 representatives. The HIV mobile testing unit van was here, also along with 9 informational booths, 42
- 8 volunteers and performances by Bob Hiltermann and CJ Jones.
- 9 Breast Cancer is a challenging project trying to find women to participate and meet the research criteria as
- we raced against deadlines. We met 89% as of March 31st.

- 12 Public Relations
- House of Blues (HOB)
- Sponsorships are lower than last year. We are waiting for sponsorship confirmations from three major
- 15 companies along with other companies. The Mayor's office has added HOB to his calendar (tentative) to
- show up at HOB. Councilmember Huizar's office will present the mock 275k check at the event. We
- found a local printer Digicolor to sponsor printing which did a great job. 108 tickets were sold out of 250.
- We need a sold out event. We appreciate all assistance we can get from the Board in selling tickets to
- 19 family, co workers, and friends.

- 31 their newsletter.

- We signed up with another film locations company which results in a potential filming a commercial here
- 34 this week.

- 38 Saturday. However, we had a good turnout of 25 parents which was considered to be a good number
- 39 especially from hearing parents. I know it is inexcusable for us to miss putting time information on our
- 40 website. We are getting bids for new facelift for our website and make it user-friendly making it easy for
- 41 us to make changes.
- 42 I am currently working on refinancing for GLAD and am working on paperwork for CDBG (Community
- 43 Development Block Grant) to get \$275k for our annex building project
- October 10, 2009 will be the date to have GLAD's 40th Anniversary Celebration.

- 26 Finance Committee Report:
- 27 Refinancing the GLAD Building
- Schultz stated that the Finance Committee recommended Option #4.

- 30 New offer from City National Bank Option #4 –
- Prepayment Penalty (as of this minutes date) \$117,467 (will be added to the new loan)
- 32 Closing Costs \$15,000 (will be paid upfront at the end of the refinancing process)
- 33 Savings from the new Monthly Payment \$3,640
- 34 Annual Savings \$43,685

35

- Option #4 is a commercial loan and the refinancing process takes approximately eight weeks. During the
- 37 first four weeks an appraiser will be hired by City National Bank will come out to GLAD building to do
- the appraisal. The last appraisal was performed in 2002.
- 39 The current loan terms with City National Bank will require GLAD to make a balloon payment in 40
- 40 months. With this refinancing of the GLAD building, the monthly payment will be reduced by \$3,640 due
- 41 to lower interest rate and will be extended for another 120 months before making a balloon payment in
- 42 year 2019.
- 43 Lovitch moves to approve Option 4. Weiss seconded. We are waiting for formal notification from LA
- Community Development Department (LACDD) regarding the extension date for paying off the \$196,000
- loan in four years. That is part of other monthly loan payment which is \$4,002. If this loan can be
- extended it will be fully paid off in year 2013. That will lead to more monthly savings of \$7,642 (\$3,640)
- 47 plus \$4,002). All in favor. **MSC**.
