MSC. 39 40 III. **OFFICER'S REPORTS** 41 President's Report: My first goal as president, in line with the 5-year plan, is to form an independent foundation group with the 42 mission to help GLAD raise at least 5 million dollars for the new building fund. Dr. Patty and I have 43 identified this individual who we believe would make a tremendous asset to the foundation group if she 44 accepts the role to lead it. Her name is Renata Simril. If she accepts the role, I believe she would be a 45 46 powerful leader based on the following as read in the December 12, 2010 Los Angeles Times article, "How I Made It: Renata Simril." She is a managing director at commercial real estate services firm Jones Lang 47 LaSalle. She advises institutional clients such as the City of Los Angeles and USC on what to do with their 48 49 real estate. It is my belief that she knows many power players in the city that she could be a great asset as a 50 leader of a foundation group to GLAD. My proposal is to come up with a strategic approach to try and

- 1 interest her to lead, or at least, help establish a fund raising arm of GLAD. Dr. Patty, John Arce, and David
- 2 Kurs will work with me in this effort to try and recruit Ms. Simril.
- 3 Another goal of mine is to encourage continuation of improvements to GLAD's website. I'm still hearing
- 4 complaints that it's not easily navigable or as user friendly for both, deaf and hearing users. This includes
- 5 improving background sounds which otherwise appear to be distracting to some hearing users. We also
- 6 need to get into media outlets especially newspapers more. We should consider exploring outside P. R.
- services to get our success stories out to wider audiences. Needless to say, the public needs to hear from us more often.

- 11 We are posting an opening in LA LS for a community interpreter position (staff) as one staff interpreter
- left to work on her academic goals. Please spread the word that we are looking for a community
- interpreter.
- 14 HUMAN RESOURCES
- 15 There is a total of 70 employees.
- We have 8 job openings. 6 are with EDD; one for Outreach Coordinator located in Bakersfield and one
- 17 Program Assistant for Health Ed and Services in LA. Mary Jane Williams, one of our longest employees
- will retire on Monday, January 31st. We wish her well and an adventurous journey.
- 19 HUMAN SERVICES
- We will have VITA (Volunteer Income Tax Assistance) from February 2nd through April 2011. It is
- 21 beneficial for people who are low income and use short forms. They will meet with tax accountants via
- videophone. It worked out well last year; thus, we will continue this year.
- We will have a Black Deaf History Month on February 5th partnering with NAOBI (National Alliance of
- 24 Black Interpreters) hosting a workshop here at GLAD.
- 25 Success: a consumer came to our advocate with good news. After months of tolerating with her roommate
- 26 who was abusive and a bully, she finally built up courage to remove her roommate from her home. She
- 27 got independent living skills and peer counseling from our advocate building up her confidence to do so.
- We had in house staff training last January 21st on social media, such as vlog, Face Book, and YouTube.
- 29 *B-GLAD*
- 30 Challenges: our consumers contacted our advocate inquiring after getting around \$100 reduction in their
- 31 SSI checks; they were unable to keep up with rent, utilities, and food. Our advocate developed a network
- 32 relationship with Community Action Partnership of Kern/Food Bank. They agreed to provide 3-5 brown
- 33 grocery bags full of bread, dry and frozen foods based on family size and income only by referral by B-
- 34 GLAD office.
- 35 We found a community room at the New Vision organization and we can use the room for once a week for
- 36 community gathering such as board meetings, socials, and workshops at no cost in exchange of allowing
- 37 three employees of New Vision's to take our ASL classes for free.
- 38 Hard of Hearing Program
- 39 Trends:
- 40 More professionals from outside hearing agencies are contacting us for information about hearing
- 41 loss/support group resources for their late deafened consumers.
- 42 Hard of hearing consumers are seeking assistance with determining appropriate accommodations at their
- 43 work place.
- 44 More deaf, hard of hearing, and late deafened consumers are seeking assistance with job placements and
- are referred to EDD.
- 46 The Annual Children's Holiday Celebration was a successful event in spite of rain. Approximately 168
- 47 children and 120 adults showed up.
- 48 *EDD*
- 49 Mary Jane Williams will be retiring after 27 years of working for GLAD. 9 placements as it was
- 50 challenging to place jobs due to rain, flood, and lack of Job Developer/Interpreter staff. We have four Job

- 1 Developer/Interpreter vacancies. We actively posted the opening and it is a huge challenge trying to fill
- 2 the void. We used Job Developer/Interpreter from the nearest EDD office to interpret for consumers from
- 3 the EDD office.
- 4 Health Education and Services
- 5 Health Fair will be held at CSDR on February 16th.
- We had approximately 75 people attending our World AIDS Day even which featured four guest speakers
- 7 (one speaker appeared remotely from Hawaii).
- 8 We are nearing the completion of developing the Breast Cancer Prevention Research manuscript.
- 9 California Department of Public Health issued two Requests for Applications, one for CCG (Community
- 10 Challenge Grant) and IE (Information and Education). We have asked the director of CCG to consider our
- special population because the RFA has been overhauled and made it impossible for us to educate deaf/hh
- 12 youth in the greater LA area as we have been doing for the past 16 years. The new RFA is restricted to
- 13 "hot spots" where high birth rates are. Students from High Schools are mainstreamed and not necessarily
- in the hot spot but their residence may be in hot spot. It put a severe restriction on our abilities to educate
- as many as we can. Hope to hear from their administrators on our request to remove the barrier from us.
- 16 Public Relations
- 17 Annual Campaign \$5,825. We sent Thank You letters right away upon receipt of donation.
- 18 Courtyard Marriott Monrovia will be presenting GLAD a check for \$2,500 for its 4th quarter fundraising.
- 19 We Do Good Awards Ladies Home Journal (LHJ). Hilari Scarl will make \$5,000 contribution to GLAD at
- the Red Carpet Gala on February 20th. LHJ originally planned to donate \$2,500 to Hilari; however, after
- 21 they learned more about the movie (See What I'm Saying) and about GLAD, they upped the donation to
- \$5,000. We are receiving it due to our community partnership with Hilari's project. The donation will be
- 23 used for our domestic violence project.
- 24 The House of Blues' date has been changed and we will release the new date soon. We are trying to secure
- 25 title sponsorship and funds for Beethoven's Nightmare (BN) performance. We will need \$15k to cover
- HOB rental and BN support. We are in negotiation with a famous celebrity hairstylist who knows how to
- sign to be the event MC.
- 28 Sprint 4G Mobile Marketing Vehicle Launch (\$5,000 facility rental agreement) on February 1st, 4 pm to 8
- 29 pm.
- 30 We will have a purse fundraiser campaign Social Butterfly campaign with Flutters, Inc (at no cost to
- 31 GLAD, \$60.00 each/100% proceeds to GLAD).
- 32 Casino Night (will need sponsors to cover production costs)
- We are in the development of Annual Report (09-10). We will need a letter from David Kurs as he was the
- 34 president during this term and Stephen Schultz will have the opportunity to write his first letter in our next
- 35 annual report.
- 36 If you stop by Eagle Rock Mall, you will see GLAD in one of its hubs and we will have an information
- booth at the Community Corner starting Feb 4th 1pm to 3 pm. It will be a monthly event.
- We will have a booth at the upcoming CAL-ED Conference March 12-14 at Doubletree Hotel in Norwalk.
- 39 Red Carpet See What I'm Saying DVD Launch Gala Event is on February 20th at Universal Studios.
- 40 *MISC*
- 41 DEMOLITION
- 42 It is now in works. We selected Interior Demolition as the company to do the abatement and demolition.
- 43 Interior Demolition is to secure bonds from Surety Bond Company to meet contract requirements. We are
- about one month behind the schedule. The City is aware and working with us on this.
- 45 AB 2072
- 46 Assembly member Mendoza called a town hall meeting last Friday to discuss how we distributed
- information to parents whose children are hard of hearing and deaf. He said it is more for his research
- 48 needs; however, it appears that his staff is pretty undetermined on what they actually need from the
- 49 townhall meeting.
- 50 Palm Springs Gala

- Will be attending Deaf Senior Foundation Gala representing GLAD and CODIE this weekend. We are
- 2 working on a small proposal with PS (Palm Springs) CDBG hoping to set up a once per month satellite
- 3 office in PS from CODIE. I will know more after I talk with some PS residents at the GALA this
- 4 weekend.
- 5 25.35
- 6 DSS' line item for ODA (Office of Deaf Access) remains untouched and we are keeping a close eye on it
- 7 to make sure there won't be any reductions to this line item.

- 9 Board Resolution
- 10 The City of Palmdale requires a Board Resolution to be passed by the GLAD Board for grant CDBG 2011-
- 11 2012 authorizing Hughes to sign the grant. Sutton moves that the Board bestow Hughes the authority to
- sign for ANY grants/proposals in order to solicit funds for GLAD. Sidansky seconds. **MSC.**
