III. **OFFICER'S REPORTS**

President's Report:

- Ron Herbold discusses the results of the election, the possible cuts and services that may come in the next 4 years
 - Ron Herbold shows appreciation for the state of California's support in GLAD's organization, providing us funding so that GLAD can continue their services.
- Ron states that GLAD has to continue with the same budget, which could be tough in the case of inflation.
- GLAD is going through an audit. Ron will bring up new business later in the meeting regarding the CEO'S bonus.
- Ron Herbold states that in the bylaws, it states that board members are to make an annual donation. He is hoping for 100% participation from all members.
- Ron opens the floor to any discussion to which Scott states that everyone in the board should contribute some sort of amount.
- Ron discusses the challenge of trying to get more members, the board has gone from 12 to 9 members. Ron introduces Ed Kelly who was a former administrator of OC Deaf, he will take over as the LifeSigns representative which was Stacey Wood's former role.

- Ron re-introduced Lauren Miller who is the representative of Tri-County GLAD, she has attended 2 meetings so far.
- Ron checks to see if the board has any other questions before continuing.
- Ron will go ahead and remind Alicia, the regional director of OCDEAF, about the need to get a representative from OCDEAF board.
- Ron tells the board to let Dr. Hughes know if they plan on attending the lunch on December 4th. Dr. Hughes clarified that there would not be a Holiday celebration, there would be a staff in-house training.

Vice President's Report:

- Scott is no longer on the board of OC Deaf as he has many responsibilities to manage. He has informed OCDEAF Board Chair.

IV. CEO's REPORT

- Dr. Hughes discusses that we are seeing more consumers being worried about the future due to the new presidency and potential new policies regarding immigration.
- GLAD has received 10-12 turkeys from LA County Board of Supervisor Hilda Solis' office. GLAD plans to distribute turkeys to consumers who need the most.
- Dr. Hughes discusses financial report, it is still in the auditing process. The auditor chose our EDD contract to focus on for the audit as well as other contracts. All necessary information is ready.
- Dr. Hughes states we got a surprise augmentation to our DSS contracts; however, the increases were not sufficient to add more personnel. The increase helped with other line item expenses.
- GLAD has been providing employment services under EDD contract for years. However, current contract, EDD asked us to provide equipment to our ES staff. We are still in the process of setting up equipment in their offices at EDD sites (8 offices). We are naming the department as GLAD Employment Services (ES). Our ES staff will work at OCDEAF, CODIE, and GLAD once a week to improve interaction between advocates and ES staff.
- Dr. Hughes talked about a new grant with Riverside Regional Center (RC) to develop surveys to ask of deaf plus individuals receiving services from RC. It is still in the development stage. Once after the RC's director signs the agreement, we will then be able to meet and discuss what kind of survey questions they want us to ask individuals. We will use different communication modes ranging from ASL to miming to get answers.
- Dr. Hughes talked about a new grant to set up counseling program at GLAD which will resulted in hiring 2.5 staff positions. It is a two year grant and we need to start working with LA Mental Health Agency to continue the service.
- On December 14th there will be a Children's Holiday Celebration at GLAD. Bakersfield GLAD
 (BGLAD) will host its annual Holiday event that includes community members and children on
 December 21st.
- Dr. Hughes had higher hopes for better and more comprehensive sidewalk project bids; however, we will need to get more information on pros and cons if GLAD should keep trees. GLAD will contact the City of LA to see if they have tree specialists that can consult GLAD.

GLAD plans to set up a meeting with the new representative in early 2025 to see if her office can find financial assistance with the mandate to retrofit the building.

CODIE Report:

- On December 18th CODIE is having high school students help wrap gifts.
- On December 19th or 20th the board is having their annual lunch gathering.
- On December 20th CODIE will be having their Holiday Drive Thru Event, it will take place behind the building again. It will be decorated with VW classic cars and lights, the Grinch and Santa will greet the children.
- There was a \$3000 donation from Inland Empire Health Plan (IEHP). The funds will be allocated for DIY craft kits for families, food items, and gifts for distribution
- It's been hard to find new members for the board, CODIE is trying to find younger people that are interested in serving on the board.

TRI-COUNTY Report:

- The Prevention and Early Intervention workshop on October 12th was successful.
