- Consolidated profit and loss for year to date (three months ending 9/30/11) shows a loss of \$(12,999) as compared to a loss of \$(691) a year ago.
- Consolidated year to date revenues as of 9/30/11 was \$1,482,155 which is \$7,434 less than prior
- GLAD's 9/30/11 net loss was (24,428) as compared to prior year net loss of (22,117).

- 25 **LIFESIGNS**
- 26 Filled Requests 887 27 Cancellations 140
- 38
- 28 No Interpreter Available
- 29 Emergency 149
- 30 The numbers represent the stability of LifeSigns (LS); however, LS needs to recruit more freelance
- 31 interpreters, especially in the Kern county and Los Angeles. Heidi Booth and Dr. Hughes are working on
- 32 this.
- 33 **HUMAN RESOURCES**
- 34 GLAD has two openings which are LifeSigns Director and one Job Developer/Interpreter for the EDD
- 35 office in Anaheim. GLAD a total of 74 employees.
- 36 The new Regional Director at OCDEAF started on October 11th. A new staff interpreter for Los Angeles
- started October 26th. 37
- 38 **PUBLIC RELATIONS**
- 39 The annual campaign letter is being printed and will be ready for distribution this week. Ken Paves, the
- 40 celebrity hair stylist, agreed to be the person to sign the annual campaign letter for us.
- After the City's Deaf Awareness on September 16th, Councilmember Huizar's new field deputy and intern 41
- 42 (a future interpreter) visited GLAD for the first time last week. They were very impressed by our services
- 43 and the beauty of the facility.
- 44 UrbanSak will continue its promotion for GLAD through the month of November. The product will be
- 45 featured at the GLAD booth at the upcoming MATA Expo. UrbanSak will donate 15% of GLAD driven
- 46 sales back to support our programs and services. Come and buy the product from us.
- 47 Flutters, Inc was featured at the DEAFestival fashion show.
- 48 The Championship Rounds (TCR the movie) campaign fundraising has launched on IndieGoGo
- 49 http://www.indiegogo.com/TCR

- 1 TCR casting has recruited Harold Perrineau Jr. and Larry Gilliard Jr. for roles in the Championship
- 2 Rounds.
- 3 GLAD hosted a booth at the 7th Annual No Limits Walkathon October 25th.
- 4 Claustrophobia: As a special thank you to GLAD for hosting the movie at GLAD, you can get \$5.00 off
- 5 when you purchase a captioned Claustrophobia DVD. Go to the website: www. Claustrophobia-
- 6 themovie.net, watch the trailer, and click on the "Order Now" button. Fill in the Promo Code Field with
- 7 GLAD. Then click on the special \$9.95 price and receive \$5.00 off the regular \$14.95 price. A portion of
- 8 the proceeds will go to GLAD.
- 9 GLAD will host 4 booths at the upcoming MATA Expo this November 11-12 at the Ontario Convention
- 10 Center. Tickets are on sale at the GLAD front desk.
- 11 Disney Project Save the Dates March 23-25. CJ Jones with Sign World Media invited GLAD to be a
- part of the planning committee for a large project involving Downtown Disney. GLAD is working with the
- committee to be a beneficiary of funds raised during the upcoming 3-day event. More details to come.
- 14 HUMAN SERVICES
- 15 Upcoming workshops:
- 16 10/28 Chronic Obstructive Pulmonary Disease (COPD) Workshop
- We had SSI and You workshop presented by SSA Public Affairs Specialist Veronica Diaz on September
- 18 24th. About 17 people showed up.
- 19 GLAD sent four advocates to take the training "Disability Rights Seminar" hosted by Housing Rights
- 20 Center where advocates learned of various applicable Landlord/Tenant rights and responsibilities.
- 21 Advocates attended the inter-department meeting (Human Services and Health Education) to work together
- 22 for future collaborative events.
- 23 TRENDS:
- Numerous medical offices with deaf/hard of hearing Medi-Cal patients have been contacting GLAD to ask
- 25 for a procedure in getting interpreters. GLAD advocates worked with the Health educators on consumer
- 26 requests and educating providers.
- 27 A consumer needed more resources to afford food. A SSA office suggests applying for food stamps since
- 28 he is receiving SSA and can qualify for additional assistance. The advocate went through the process on
- 29 how to get food stamps with the consumer. The consumer went to apply for food stamps and felt
- 30 empowered with information/resources since he was able to get food stamps successfully. Our advocate
- 31 worked with him on how to use an EBT card (food stamps in a debit card).
- 32 We sent an advocate to work with a consumer in court to see that she had communication access for her
- child custody case. Two sets of interpreters and two CDIs showed up. The advocate reviewed
- 34 questions/discuss with the consumer about what to ask was being discussed with the attorney. She was able
- to make informed decisions on the custody/visitation case.
- 36 BGLAD
- 37 Challenges: Interpreters are very scarce in Bakersfield. We had 10 complaints from consumers that they
- did not have interpreters during their stay at hospitals or medical appointments. The consumers were
- 39 encouraged to reschedule their appointments later in the day in order to take advantage of interpreter
- 40 availability because many interpreters are working at schools.
- 41 Section 8 programs in Kern County are closed and consumers have experienced financial hardships as they
- 42 are unable to find affordable housing. Consumers have been referred to epath.org (a program for homeless
- 43 individuals) and local housing authorities.
- 44 Success:
- 45 An advocate assisted a consumer with Medicare coverage back in 2007. The consumer had an old bill that
- 46 was redirected to a collection agency. The consumer learned that Medicare used Worker Compensation
- 47 Insurance as the primary insurance in 2007 and the medical bill was denied. The advocate and the
- 48 consumer were able to convince Medicare to go back to 2007 and change the primary carrier to Medicare.
- The consumer finally got the bill with the zero balance.
- 50 BGLAD will have an open house on November 17th that Hughes will be attending. There will be a

- 1 meeting with DOR representatives in Bakersfield on the 18th. Hughes will be attending this meeting.
- 2 HARD OF HEARING PROGRAM
- 3 TRENDS: We continue to receive requests to be referred to low cost hearing aid dealers and lip reading
- 4 classes.
- 5 Support Group: ONLINE Support Group for Hearing Loss facilitated by our Hard of Hearing Specialist
- 6 through Facebook included: Personal Accommodations, family events, and holidays, medical
- 7 appointments. Some HoH/LD consumers remain dependent on a hearing spouse or family member to hear
- 8 fire alarms or children crying despite availability of baby cry/fire equipment/alerts. Issues like these are
- 9 being addressed in support group.
- For ongoing discussions we have about 54 to 75 participants. More consumers offer each other support and
- different approaches on coping skills.
- GLAD will have the 28th Annual Children's Holiday Celebration on December 3rd.
- 13 DAHC
- We plan to offer low impact exercise for residents. The residents signed a waiver form and obtained
- doctors' notes. GLAD applied for a grant to get a van from the Ahmanson Foundation.
- Hughes gave a grand tour of GLAD facility to a representative from the Ahmanson Foundation. We had a
- good meeting talking about GLAD and general programs. The representative said that it usually requires
- about four to six weeks hearing back from the foundation if our request will be granted.
- 19 *EDD*
- 20 Our Anaheim office made 13 job placements due to high number of recruitment from Knott's Berry Farm
- for the Halloween season. More consumers are seeking retail jobs due to a large number for seasonal jobs
- in the next three months. It is true for all of our other EDD offices.
- 23 The trends and challenges remain the same. It is becoming frustrating for consumers to continue seeking
- 24 employment after being rejected many times. Our EDD staff is trying to keep their interests in finding
- employment through sending consumers to Job Fairs, making cold calls to companies, and persuading
- 26 employers to hire our consumers.
- 27 Another challenge is that consumers heard from other consumers who had great jobs at places like Coke or
- Walgreens distribution centers. They want the same thing; however, they may lack necessary skills or
- 29 experience. EDD developers work with Department of Rehabilitation to see about having consumers take
- 30 vocational training or encourage consumers to get a job at an entry level that potentially will increase their
- 31 experience.
- 32 HEALTH EDUCATION
- 33 The Health Department is preparing for the GLAD's World AIDS Day event set for December 2nd.
- A new consumer asked for guidance from our healthcare access case manager on how to find a doctor. The
- 35 consumer did not know that his Medi-Cal has been changed and assigned to LA Care. Our case manager
- worked with him to get it in order.
- 37 *MISC*:
- 38 Dr. Hughes has been reviewing 1,500 pages worth of documents for her deposition to be given next week.
- 39 It is about a lawsuit filed by a law student against a university for not providing her communication
- 40 accommodations.
- 41 She is also working with DRA (Disability Rights Advocates) attorneys on our CNN.com lawsuit. There
- will be a court hearing on December 1st. It is possible that Dr. Hughes will be at the court hearing in
- Oakland and will be determined in the very near future.
- Our lawsuit against the state's Office of Family Planning is still in process. GLAD is working with DRLC
- 45 (Disability Rights Legal Center) attorneys on collecting narratives from parents who want to have GLAD
- 46 continue to provide Teen Pregnancy Prevention program.
- 47 The California Coalition of Agencies Serving Deaf and Hard of Hearing met in Fresno last week to go over
- 48 issues. Our last meeting was in 2009. Jim Brune, Executive Director from DCARA was elected to be the
- 49 new chair and Amy Grindrod, our regional director at OCDEAF was elected to be the new secretary. We
- will send a letter to the Chief of Deaf Access Program at the Department of Social Services requesting that

1 a meeting be set up to discuss the new budget modification rules and what the future is for our 8 agencies.

2 ANNEX LOT

The board discussed what was to be done with the annex lot while they are trying to raise funds for the new 3 4

building. Discussion ensued. The discussion was tabled till next the next board meeting. No official

motion was passed.

V. SUBSIDIARY REPORTS

LIFESIGNS Chair Report:

9 Arce reported that the LifeSigns (LS) board met yesterday. The LS board discussed the Agenctrak1000 10 (AGT) the online database for interpreter requests. LS is trying to become paperless by transitioning AGT

- the online database. Some of LS customers are used to faxing interpreter requests but LS staff is slowly 11 getting LS customers to use the AGT online rather than faxing interpreter requests. AGT makes is easier
- 12 13 for interpreters to complete jobs. The GLAD board inquired why LS has taken so long to transition to
- AGT. Hughes explained that since AGT was not custom made for LS but rather created for all interpreting 14
- 15 agencies there are several issues that have popped up. Dataweb the company that created and runs AGT is
- building a custom online database for LS. Becoming paperless is a slow but successful process for LS. 16
- Hughes explained that LS is not looking for a LS Director right now because she is considering a possible 17
- 18 restructure. Hughes would like to split the position into two positions, a manager to manage the LS staff
- 19 (Booth is managing LS staff temporarily) and a subcontractor that would report directly to Hughes that is
- 20 solely focused on marketing LS. The board will meet again in January 2012.

21 22

DAHC Chair Report:

- 23 Hughes informed the board that they will start a low impact exercise class for residents but will require the 24 residents to obtain a doctor's note saying they are physically fit enough for the class and to sign a waiver.
- HUD (Housing and Urban Development) has not paid GLAD since last September. GLAD has a long 25
- 26 waiting list for the 14 apartments on the third floor.

CODIE Report:

29 Kurzet inquired if GLAD's stove could be used for events. Hughes explained that it may have gas leak 30 and in the past the committee for the kitchen had deemed that it was the wrong kind of stove but Hughes 31 will check into it.

32 33

TRI COUNTY Report:

- 34 Sidansky reported that Tri-County GLAD will have a booth at the Strawberry Festival again in 2012. The
- 35 fee for the booth will be waived for 2012 since Tri County GLAD won an award last year for the best
- decorated booth at the Strawberry Festival 2011. All of the items that will be sold at the booth will cost 36 37 \$3.00. The Tri board will be giving a 2012 calendar as a gift to Tri staff for the holidays to show the
- 38 board's appreciation. Sidansky explained that in 1995 the Ventura Fair had a deaf house demonstrating the
- 39 equipment that the deaf used. Tri County GLAD will build another deaf house with current technology for
- 40 the Strawberry Festival.
- 41 Sidansky explained that the size of the support group Mothers of Deaf Children has increased.
- Tri-County GLAD received \$50,000 from Ventura Behavioral Mental Health to serve the deaf and hard of 42
- 43 hearing community.
- 44 The Ventura prison is in process of installing the new Sorenson ntouch video phone for the deaf inmates.

OC-DEAF Report:

- 47 Jones reported that the board finally met Amy Grindrod the new Regional Director for OCDEAF. The
- board wanted to give Grindrod a fresh start as Regional Director so they asked her to create a wish list for 48
- 49 things she would like to improve in the office. OCDEAF will have an open house to meet the board and
- 50 Grindrod. The board is still discussing a date. One thing Grindrod would like to improve is the OCDEAF

1 website.

2 Jones informed that OCDEAF may have made about \$200-\$400 from Deaf Awareness Day at Knott's

3 Berry Farm.
